SUMMARY ANNUAL REPORT

FOR I.A.T.S.E. LOCAL 504 HEALTH AND WELFARE TRUST FUND

This is a summary of the annual report of the I.A.T.S.E. Local 504 Health and Welfare Trust Fund, E.I.N. 95-6100367, Plan No. 501, for the year ended June 30, 2021. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Kaiser Permanente, United HealthCare Insurance Company, Delta Dental Plan of California and The Union Labor Life Insurance Co. to provide certain medical, dental, life insurance and accidental death and dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ended June 30, 2021 was \$924,311.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$1,418,019 as of June 30, 2021, compared to \$1,514,137 as of July 1, 2020. During the plan year, the plan experienced a decrease in its net assets of \$96,118. During the plan year, the plan had total income of \$826,470 including employer contributions of \$810,581, participant contributions of \$3,169 and gains from investments of \$12,720.

Plan expenses were \$922,588. These expenses included \$807,845 in benefits paid to or for participants and beneficiaries and \$114,743 in other expenses.
